# **VVEX Tech Privacy Policy**

VVEX Tech ("we," "us," or "our") respects your privacy and is committed to protecting the personal information you provide when accessing our website (<u>https://vvextech.app</u>), games, and blockchain-based services (collectively, the "Platform"). This Privacy Policy explains how we collect, use, and safeguard your information.

# 1. Information We Do Not Collect

- We do **not collect or store your personal data**, such as your name, address, phone number, or government-issued ID.
- We do not store your private keys, wallet credentials, or passwords.
- We do **not collect any payment or credit card information** directly. All payments are made via blockchain wallets.

# 2. Information We May Collect Automatically

When you visit our Platform, we may automatically collect limited technical information, including:

- Your IP address
- Browser type and version
- Device type and operating system
- Referring website (if applicable)
- Timestamp and activity logs

This information is used solely for security, analytics, and troubleshooting purposes and is never linked to personal identities.

## 3. Wallet Interaction

You may connect your non-custodial wallet (e.g., XUMM) to interact with the Platform. We may log your public wallet address and transaction metadata strictly for the purpose of:

- Verifying game-related actions
- Delivering NFT or token-based services
- Automating donation acknowledgments or discretionary rewards

Wallet addresses are public by nature and are not associated with personal identity by us.

## 4. Cookies & Analytics

We may use basic cookies or third-party analytics tools (e.g., Google Analytics) to:

- Monitor website traffic
- Improve user experience
- Diagnose technical issues

You can disable cookies through your browser settings if desired.

#### 5. Data Sharing

VVEX Tech does **not sell, trade, or rent user data**. We may share limited technical data only in the following cases:

- To comply with a lawful request from government authorities
- To protect our rights, users, or infrastructure

## 6. Third-Party Services

Our Platform may link to third-party services such as wallet providers or NFT marketplaces. These third-party sites operate under their own privacy policies. We are not responsible for their data practices.

## 7. Data Security

We implement reasonable security measures to protect our systems, including encryption, firewall protection, and limited access protocols. However, **blockchain interactions are inherently public and irreversible**, and we cannot prevent data disclosure via third-party block explorers or wallet tools.

#### 8. Children's Privacy

VVEX Tech is not intended for children under 18. We do not knowingly collect any information from individuals under the age of 18.
